FEMA to Award Hazard Mitigation Planning Grants to Local Governments

The Federal Emergency Management Agency has notified the State of Maryland that eight Hazard Mitigation Planning Grants applied for under the Pre-Disaster Mitigation Grant Program (PDM) have been selected for further review. This is the final step before actual award in the competitive grant process under the PDM grant program

The eight jurisdictions applied for a total of \$279,000 in Federal funds to update their hazard mitigation plans. Federal law requires that all local hazard mitigation plans be updated on a five year basis in order for local governments to remain eligible for hazard mitigation funding. These plans are all hazards in nature, although flooding figures prominently in each jurisdiction's planning document.

The jurisdictions which are to be awarded funding include Allegany, Garrett, Montgomery, Queen Anne's, Somerset, and Washington counties as well as Baltimore City.

MAFSM Donates to the Gilbert White Memorial Fund

MAFSM recently donated five hundred dollars to the Gilbert White Memorial Fund. Dr. White was one of the most celebrated geographers of the past century. He raised our nation's awareness of the hazards people assume when living in and near flood zones. The Gilbert White Memorial Fund will be used to construct a flood marker along Boulder Creek in Boulder, Colorado. This flood marker was designed by Mary White, an eco-artist and Gilbert's daughter, and Christian Muller, a local artisan who created Boulder's Sister-City Plaza. It is made of sculpted granite and smoothed recycled transparent jade float glass, which was chosen for the top part of the marker because it reflects light and movement, like water. The stone base is an excellent surface for engraved text and discourages climbing and vandalism. LED lights, powered by water or solar energy, will illuminate the core of the glass obelisk. STORMWATER MANAGEMENT IN MARYLAND UPDATE

The State of Maryland Department of the Environment (MDE) has been busy updating their regulations pertinent to soil erosion and sediment control, and stormwater management.

Soil Erosion and Sediment Control

In 2009 a comprehensive review of the 1994 standards resulted in a draft of the "2010 Maryland Standards and specifications for Soil Erosion and Sediment Control". Released in October 2009, this document provides guidance to applicants, designers, plan reviewers, developers, contractors, and inspectors to control sediment runoff from construction sites.

This document now contains a planning element, which is important for today's site design measures, especially since designs are required to meet Environmental Site Design (ESD) and Maximum Extent Practicable (MEP) stormwater requirements.

MDE has been working with many organizations, including the Natural Resources Conservation Service (NRCS) and the Maryland Association of Soil Conservation Districts (MASCD), through a technical review workgroup as part of the development and updating process. Currently this document is scheduled for a May 30, 2010 incorporation. The following are the MDE web sites where additional information can be obtained

Stormwater Management

The Stormwater Management Act of 2007 requires that environmental site design (ESD) be utilized to the maximum extent possible (MEP). As part of the program local governments are required to implement an ordinance that establishes these regulatory requirements. These regulations became effective May 4, 2009. Within the regulations is a statement that unless approval of final erosion and sediment control plus stormwater management project plans is received before May 4, 2010, the design must comply with the new requirements.

After discussions concerning the regulations, MDE added guidance for three categories: grandfathering, redevelopment, and smart growth. This action was to be submitted as emergency legislation. In early March, it appeared that this objective had been achieved through a compromise led by Del. McIntosh. However, the compromise effort fell apart, with the environmental community supporting the regulations that are effective May 4, 2010. With only days left in the state legislative session the Act remains unchanged.

MAFSM 5th Annual Conference Recap
