## Maryland Floodplain Managers, Spread the Word

Residents, community groups, water management authorities, and elected officials are turning to floodplain managers as influencers on any number of potentially controversial topics—from how new flood hazard maps affect flood risk, to the integrity of local levees, to the need for and availability of flood insurance. In Maryland, when floods threaten the homes and businesses of the State's 5.6 million residents, it is the local floodplain manager that they often turn to for information on what's going on, why it's happening, and what to do next.

By understanding the local flood risks, learning the issues that change or increase these risks, and utilizing the necessary resources and tools, you can help residents protect lives and property and reduce future flood risks. As a floodplain manager, it's not too late for you to engage in proactive outreach to your community. You can help residents prepare for dangerous weather-related events and protect themselves financially.

### **Maryland Flood Risks:**

The State is hit with high winds, significant rainfall and storm surge **from hurricanes and tropical storms**; these can move hundreds of miles inland. Flooding can be a year-round concern; the State is susceptible to **heavy rainfall** and flooding in the spring and summer months—and these risks can increase with **melting snow**. Maryland is currently having its **flood maps modernized** to provide an updated picture of the levels of flood risk in each county. The level of protection that levees provide is also being incorporated into these new flood maps.

### Floodplain Managers Role:

As a floodplain manager, you can help reduce community vulnerability by sharing information about flood risks and flood insurance. Your role in educating the public prepares communities for flood disasters and helps them recover. Now is the time to join forces with local insurance agents and elected officials and notify your community about the risks of flooding and the rewards of flood insurance. We need to remind Maryland residents that where it can rain, it can flood, and where it has already flooded, it will likely flood again. Residents should take steps to prevent devastation from future disasters. These efforts strengthen the National Flood Insurance Program (NFIP) and help maintain its ability to support the work of floodplain managers.

## **MAFSM 3rd Annual Conference**

MAFSM held their 3<sup>rd</sup> Annual Conference on October 24<sup>th</sup> and 25<sup>th</sup>, 2007 at The Conference Center at the Maritime Institute in Linthicum Heights, Maryland. This year's conference was themed *Stormwater and Floodplain Management in Maryland - The Local Perspective* and was attended by 120 people.

This year's event featured two pre-conference activities—a coastal plains outfalls tour in Anne Arundel County and a Certified Floodplain Manager (CFM) training. Theses activities were followed by a full-day conference with 14 breakout sessions on a wide array of local floodplain and stormwater issues, exhibits, and a social hour. A CFM exam was also held in conjunction with the conference on October 26<sup>th</sup>.

The field tour, attended by 15 people, began at the Arlington Echo Nature Preserve. Attendees were then taken to a series of engineered ponds with stone weirs that were placed to help restore deeply

eroded streams and their floodplains to a more natural condition, while providing infiltration of runoff for stormwater management and preventing erosion in the receiving stream. Each site illustrated different sized projects and conditions, from steep narrow outfall areas to fairly flat and wide stream valleys.

The CFM training covered topics such as the National Flood Insurance Program (NFIP) regulations, community participation in the NFIP, reading and using Flood Insurance Rate Maps, insurance, mitigation, and other topics. It was an excellent supplement for those studying for the CFM exam as well as a great refresher course for CFMs. Twenty-seven people attended the training and it received universal positive evaluations.

The conference was kicked off by keynote speaker, General Gerald E. Galloway, Jr., P.E., Ph.D., noted civil engineer, public administrator, soldier, educator, and geographer. We were privileged to have him open our conference. Mr. Galloway's address was followed by concurrent sessions that included *Activities of the Maryland Hydrology Panel*, *Patterns of Headwater Stream Burial Due to Urbanizations in the Gunpowder-Patapsco Watershed*, and more.

Lunch included a Business meeting, an update by ASFPM's Region III Director, Jeff Sparrow on ASFPM activities, and a talk from Vince DiCamillo on the ASFPM Foundation. Following lunch, attendees had time to network in the exhibit hall before the afternoon concurrent sessions began. These sessions included *Overview of Low Impact Development, Dorchester County, MD: Sea Level Rise Inundation Study*, and others. The conference was closed by Ken Pensyl, Program Manager, Sediment and Stormwater Division of the Maryland Department of the Environment. An hour-long networking social concluded the evening.

# MD Stormwater Management Act Update

On April 24, 2007, the "Stormwater Management Act of 2007" was signed by Maryland Governor O'Malley. The new act will go into effect on October 1, 2008. For this to occur, a multitude of drafting, planning and scheduling activities are taking place.

Prior to the passage of the Stormwater Management Act, stormwater management requirements for new development were provided in accordance with the unified sizing criteria consisting of water quality volume, groundwater recharge volume, channel protection volume, overbank protection volume and extreme flood volume. These criteria are outlined in the 2000 Maryland Stormwater Design Manual. Chapter 5 of the 2000 Manual, "Stormwater Credits for Innovative Site Design Planning", encourages the use of Environmental Site Design (ESD). Stormwater "credits" were granted accordingly for using ESD. In general, ESD uses small-scale stormwater management practices to minimize the impact of land development on water resources. The most significant change that will result from the SWM Act of 2007 is that ESD is required to the maximum extent practicable and to ensure that the structural practices are used only where absolutely necessary.

It is the responsibility of the Maryland Department of Environment (MDE) to implement these new regulations and make necessary changes to the 2000 Maryland Stormwater Design Manual. A meeting was held July 30, 2007 to discuss ideas for developing regulations that will implement ESD as required by the Act. Short term activities that came out of this meeting were to redraft Chapter 5 of the SWM Manual. The redraft includes information on current design practices

and changes in decision making for implementing ESD. Since the Manual is incorporated by reference into the Code of Maryland Regulations (COMAR), it can be updated without a significant re-write of the regulations. In updating the manual to reflect the ESD as a required technique, MDE believes it will meet requirements of the SWM Act within the required timeframe.

A 66-page first draft of Chapter 5, dated December 14, 2007 is available on MDE's web site. The requirements of the Stormwater Management Act of 2007 are outlined and detailed.

Throughout January and February, six regional focus group meetings have occurred to discuss proposed changes. By May, MDE hopes to finalize design standards and schematics, prepare technical guidance, and draft any necessary regulation changes. In addition, MDE will work to develop a model ordinance that can be used by municipalities in Maryland. Through the summer of 2008, it is anticipated that COMAR modifications will be published and public comments will be requested. Regulation circulation will begin in September 2008 with the ultimate goal of adopting the new regulation by the end of 2008.

Stormwater management regulations have been evolving since 1982 when the first SWM statute was passed in Maryland. The evolution of SWM regulations continues with the implementation of the SWM Act of 2007. This act will significantly affect the approach to controlling stormwater in Maryland.
