# Check Out the New Additions to Your Conference This Year!

#### Hurricane Agnes Site Tour of the City of Laurel

In 1972, the City of Laurel, Maryland was impacted by Tropical Storm Agnes. Several bridges were destroyed and large areas of the city were impacted by some of the worse flooding Maryland has experienced. On top of this, their dam was at capacity and posed a huge threat.

As a precursor to MAFSM's 2<sup>nd</sup> Annual Conference and General Membership Meeting, we are offering a field trip that will take participants on a tour of portions of Laurel that was affected by the disaster. Joe Robinson, Fire Chief during Agnes and former Mayor of Laurel, will speak. He will share his experiences of the City of Laurel's response, including what changes were made to address future flood events. Mr. Robinson is also a local historian and will discuss other floods that impacted the city. The field trip will include a short tour where the destruction of Agnes is still visible over thirty years later.

The half-day event is scheduled for October 18<sup>th</sup>, 2006 and is free of charge to MAFSM members. Meet at the Laurel Museum at 817 Main Street in Laurel, MD at 1pm on the 18<sup>th</sup>.

Those who participate in the field trip will be eligible for two parallel Continuing Education Credits (CECs) through the Association of State Floodplain Managers (ASFPM) to maintain their Certified Floodplain Manager (CFM) certification.

#### **CFM Training**

An all-day Certified Floodplain Manager (CFM) training course, The NFIP: An Overview, will be held on Wednesday, October 18th, 2006, from 9:00 am to 4:30 pm, at the National Wildlife Visitor's Center in Laurel, Maryland, with the National CFM Exam to be held on Friday, October 20, 2006, at 3:00 pm at Greenhorne & O'Mara's National Headquarters at 6110 Frost Place, Laurel, Maryland, 20707 (find directions at <u>http://www.g-and-o.com/locations/laurel.htm</u>).

This course is a good refresher course even for current CFMs, who can claim six pre-approved Continuing Education Credits from the Association of State Floodplain Managers (ASFPM) for attendance. For attendees who are not yet CFMs, this is a great refresher course but will not take the place of intensive study.

Prior to this training, we recommend that you read the manual, Floodplain Management Requirements: A Study Guide and Desk Reference for Local Officials (FEMA 480), available for download at <a href="http://www.floods.org/Certification/FEMA\_480.asp">http://www.floods.org/Certification/FEMA\_480.asp</a>. This manual is lengthy - so please give yourself some time to prepare!

Please note that signing up for this course does not automatically register you for the CFM Exam, and signing up for the exam does not register you for the course. To sign up for the exam, you must register through ASFPM. Go to <u>www.floods.org</u> and click on "Certification" for more information about the exam and to obtain applicable forms and fee schedules. ASFPM requires that you register and submit payment at least two weeks in advance of any CFM exam.
